Dear Ms. Haas,

Upon further review of my Financial Disclosure documentation for 2015, it has come to my attention that the date I stated for the inheritance of my one-third share in my family's farm was incorrect. After my mother's death in October 1990, a final distribution of her assets was filed with the California court system on February 24, 1992. As such I'm requesting that my filings for calendar years 1992-2014 be updated to reflect the following:

"R.L. Young Farm: I hold a one-third interest in a family farm that was inherited on February 24, 1992. The farm is located in Meridian, CA and produces crops of walnuts, beans and grains. My older brother, Russell, solely manages and operates the property as his primary farming business. I have a non-controlling interest in the family farm, do not participate in operations or management decisions, and do not receive direct income from farm operations."

While going through documents to confirm the correct date of acquisition, I discovered that for calendar years 2001 – 2003 I failed to disclose delayed lease payments for an oil and gas lease on the property. As such I'm requesting that my filings for calendar years 2001 – 2003 be updated to reflect the following on Schedule III:


And for calendar year 2004 on Schedule IV:
